All smoke free premises and vehicles will have to display **No Smoking** signs that meet the requirements that are set out in the Smoke-free (Signs) Regulations.

What signage you will need to display?

No-smoking signs in premises

From Sunday 1st July 2006, No Smoking signs will need to be displayed in a prominent position at every entrance to smoke-free premises. Signs must meet the following minimum requirements:

1. be a minimum of A5 in area (210mm x 148mm),
2. display the international no-smoking symbol* at least 70mm in diameter,
3. carry the following words in characters that can be easily read:

"No smoking. It is against the law to smoke in these premises".

A smaller sign consisting of the international no-smoking symbol at least 70mm in diameter may instead be displayed at entrances to smoke-free premises that:

1. are only used by members of staff (providing the premises displays at least one A5 area sign with words, as set out above), or
2. are located within larger smoke-free premises (for example, a shop within an indoor shopping centre.)

No-smoking signs in smoke-free vehicles

Smoke-free vehicles will need to display a No Smoking sign in each compartment of the vehicle in which people can be carried. These no-smoking signs must display the international no-smoking symbol at least 70mm in diameter.

** The international no-smoking symbol consists solely of a graphic representation of a single burning cigarette enclosed in a red circle of at least 70mm in diameter with a red bar across it.*

What are the penalty amounts?

The penalties and fines for the smoke-free offences set out in the Health Act 2006 are:

- Smoking in a smoke-free premises or vehicle: a fixed penalty notice of £50 (discounted to £30 if paid within 15 days from the issue of a notice) or a fine by a court not exceeding level 1 on the standard scale (up to £200)
- **Failure to display no smoking signs in smoke-free premises and vehicles as required by the new law: a fixed penalty notice of £200 (discounted to £150 if paid within 15 days from the issue of a notice) or a fine by a court not exceeding level 3 on the standard scale (up to £1000)**



- Failing to prevent smoking in a smoke-free premises or vehicle: a fine by a court not exceeding level 4 on the standard scale (up to £2500)
